he exhibition, History and Heritage: The Jewish Community of Nova Scotia, is the

culmination of a two-year mission by the Jewish Historical Society of Halifax. Members of the society diligently and lovingly gathered memorabilia, asked questions, and documented material. Today they can say with pride, "Happy are we. How goodly is our portion, how pleasant our lot, how beautiful our heritage."

The exhibition tells the story of immigrant stock from Central and Eastern Europe, who transplanted their heritage, their customs and their practices in a new land ... and they bore fruit. Once settled in the towns and villages of Nova Scotia, they looked beyond their own family and their own people, and like all immigrants who came, made a contribution to the cultural and social fabric of this province.



The history of the Jewish people spans more than 4000 years. The exhibit represents an illustrated narrative that travels along a

Ribbon of Time. It begins by identifying landmark events in the history of the Jews beginning with the patriarch Abraham and leading up to the eighteenth century when Jews who suffered oppression in Central and Eastern Europe, sought refuge in America. They came. They planted the seeds of freedom and enterprise that were denied them in the 'old country'.



Who were these early Jewish settlers? Where did they settle? The exhibit seeks to answer these questions using ship manifests, marriage

contracts, family portraits, and scenes of life in Halifax as well as small communities such as Springhill, Glace Bay, and Yarmouth. Throughout, there is evidence of the ties to an ancient tradition. At the same time, the newcomers realized that they must contribute to the economic, cultural, and social progress of the community in which they lived, and they did this with vigor and commitment.



"The ideas and ideals of a people may give it significance but its group habits give it life."
This expression can find no better meaning

than in the Jewish people's commitment to its religious Festivals and Holy Days. The exhibition reflects this bond through a variety of illustrations, ceremonial objects and artifacts. In addition, the role of the Synagogue in the life of the immigrants is graphically depicted.



A wise sage of old once said: "The Jewish home has rarely been his castle; throughout the ages it has been something far higher —

his sanctuary". The home, the cornerstone of Jewish family life, and the rituals associated with birth, bar and bat mitzvah, marriage, death and mourning are recreated in the Cycle of Life. This cycle, along with two other significant events — the Holocaust, and the establishment of the State of Israel add a further dimension to the history and heritage exhibit.

Dear Sir:

I called you when I was in Halifax at the end of July, but found you were away on vacation.

In any event I had the opportunity of seeing the wonderful History and Heritage Exhibition that your historical society presented at the Nova Scotia Archives, and had, as well, an opportunity of seeing some of the documents in the archives' file which they had apparently obtained from your society.

I have one question arising out of the Jan Goeb manuscripts on the Maritime Jewish Community that you were good enough to send me in May. If you could advise me how to reach him I could write him directly.

My question relates to Mr. Goeb's information at the bottom of page 14 of his manuscript that in 1769 Samuel Hart gave his five year old son, Moses Montague Hart, to his brother Montague to raise and educate, and that Moses Montague never returned to Canada. While Mr. Goeb cites the Samuel Hart Probate Court records (H-42) as the authority for this and other information, I believe he must have some additional reference for the facts outlined above.

Any assistance you can give me in this connection would be greatly appreciated.
